The following notification will be published in the next issue of Extraordinary Andhra Pradesh Gazette:

NOTIFICATION

In exercise of the powers conferred under section 3 (4) of the Unorganized Workers’ Social Security Act, 2008 (Central Act No.33 of 2008), and in supersession of the Notification issued in the G.O. 1st read above, the Government hereby notify the “Chandranna Bima”, a Social Security Scheme to provide of Rs.5.00 Lakhs (Rupees Five Lakhs only) Accident Death and Disability Insurance and also other benefits for the Unorganised Workers in the State, and the details of the scheme are appended to the Annexurs - I, II and III to this notification.

UNORGNISED WORKERS AND OBJECT OF THE SCHEME:

No. of Unorganised Workers in the State:

As per the Planning Department Statistics, there are 2.33 Crores Main and Marginal Workers in the State. As per Government of India, 88% of the total workers are unorganized workers. Hence, it is estimated that 2 Crores Unorganised workers are to be registered in the State. During the Praja Sadhikara Survey, 1.50 Crores Unorganised Workers have been identified so far out of 3.47 Crores persons enumerated and another 50 lacs are expected to be enumerated by the completion of the survey.

Object of the Scheme:

The main object of the scheme is to provide relief to the families of unorganized workers in case of death or disability of the unorganised worker leaving the families in great distress.

All India statistics indicate that Andhra Pradesh is one of the States with large number of accidents. The death or disability due to accident of an unorganized worker results in misery to his family and hardship caused by reduced earnings and medical and other expenditure relating to the accident. Hence, there is every need to provide accident death and disability insurance to the worker towards social security. Further, even natural death of an unorganized worker results in undue hardship to the surviving family members who need to be provided some relief.

Government had already implemented social security scheme to the transport drivers in the unorganized sector on pilot basis and on the working experience of the said scheme, it is felt appropriate to extend the social security scheme to all

unorganized workers in the State with certain modifications to provide disability coverage also.

SALIENT FEATURES OF THE SCHEME

1. All unorganised workers in the State in the age group of 18 to 70 years and drawing monthly wage of Rs.15,000/- or less are eligible to be registered as unorganised workers and enrolled as beneficiaries of the Chandranna Bima Scheme.
2. All unorganised workers will be registered under the Unorganised Workers Social Security Act, 2008 through the Praja Saadhikara Survey being conducted by the State Government and enrolled as beneficiaries under Chandranna Bima Scheme.
3. SERP shall maintain data base, hard copies of signed applications and other connected matters.
4. Assistant Labour Officer of the Labour Department shall be the Registering Authority.
5. The benefits under the Chandranna Bima Scheme are as follows:

(i) Rs. 5,00,000/- (Rupees five lakh) Accident Death and total disability relief:

Rs. 4,25,000/- (Rupees four lakh twenty five thousand) from State Accident Death and Disability Scheme, Rs.75,000/- (Rupees seventy five thousand) under Aam Admi Bima Yojana (AABY).

(ii) up to Rs.3,62,500/- (Rupees three lakh sixty two thousand five hundred) Permanent Partial disability relief:

Up to Rs. 3,25,000/- under State Accident Death and Disability Scheme – Rs.37,500/- under Aam Admi Bima Yojana (AABY)

(iii) Rs.30,000/- (Rupees Thirty thousand only) Natural Death relief under Aam Admi Bima Yojana (AABY).

(iv) Rs.1200/- p.a. towards scholarship per child up to two children of the beneficiary studying 9th, 10th, Intermediate or ITI.

Note:

- a. The Benefits under the Aam Admi Bima Yojana Scheme are available to the Unorganised Workers in the Age Group of 18-59 years only and the Benefits under State Group Insurance Scheme are available for the age group of 18-70 years.
- b. In view of the difficulties in operationalisation of the PMSBY Scheme proposed in the G.O. 1st read above, for the current year Group Accident Insurance Scheme may be implemented for Rs.4.25 lacs extending the benefits as contemplated in GOMs No. 36 Dt: 17.06.2016.
- c. All eligible workers as per Chandranna Bima Scheme shall get Rs.5 Lacs Accident Death Insurance/Total Disability from the date of launching, irrespective whether they were surveyed already or going to be surveyed, as the survey is still continuing.
- d. The total premium for the AABY Scheme and the Group Accident Insurance Scheme shall be paid from the A.P. Building and Other Construction Workers Welfare Fund immediately as an Advance which shall be repaid by the respective Welfare Funds and by the Government from the Budgetary provision for Welfare Schemes / additional provision for new category of workers, in proportion to their workers covered by the Chandranna Bima Scheme, as per the Orders of the Government that will be issued from time to time.

6. The beneficiary is required to pay to SERP Rs.15/- to meet the expenditure on registration and enrolment of unorganised workers, data entry, maintenance of hard

copies of signed applications and other connected matters, communicating the Policy details with Policy Number and the Benefits, honorarium / incentive to Bima Mitras for claims investigation and support to nominees for filing of claim applications and Zilla Samakhyas Insurance Call Center management and scholarship processing.

7. All Zilla Samakhyas, Mandal Samakhyas, village Samakhyas, Slum Level, Town/ City Level Federations are hereby notified as Workers Facilitation Centers under section 9 of the Act, for facilitation of registration of unorganised workers, their enrollment in social security schemes, processing of claims and for delivery of such other services required for implementation of the scheme.

8. The details of the scheme and modalities of implementation of the scheme shall be as specified in the Annexure appended to this Notification.

CHANDRANNA BIMA SCHEME

PRELIMINARY

1. SHORT TITLE, EXTENT, APPLICATION AND COMMENCEMENT:-

1. The scheme may be called "Chandranna Bima"
2. It extends to the whole of the State of Andhra Pradesh.
3. It shall apply to all Unorganised Workers in the State subject to their fulfilment of the eligibility criteria
4. It shall come into force from the date specified by the Commissioner of Labour;

2. DEFINITIONS:-

In this scheme, unless the context otherwise requires,

- (a) "AABY" means the Aam Admi Bima Yojana Scheme of the Government of India implemented through Life Insurance Corporation of India.
- (b) "Act" means the Unorganized Workers' Social Security Act, 2008.
- (c) "Chandranna Bima Beneficiary" means an Unorganised Worker getting monthly income upto Rs.15,000/- per month and is in the age group of 18 to 70 years registered under the scheme (Illustrative list of unorganised workers as per Annexure III) and includes Small and Marginal Farmers;
- (d) "Family" relating to a beneficiary shall be deemed to consist of the beneficiary, his/ her spouse, son up to 21 years of age, unmarried daughter, widowed daughter if residing with the beneficiary, dependent parents and the widow and children of a deceased son, if any;
- (e) "Fund" means "Andhra Pradesh Unorganised Workers Social Security Fund" constituted under Clause 3 of the Scheme;
- (f) "Implementation Agency" is the Society for Elimination of Rural Poverty (SERP)
- (g) "Identity Card" as per Section 10(3) of the Unorganised Workers Social Security Act, 2008 shall mean the "Chandranna Bima Identity Card" issued under the Scheme with Unique Identity Number and Policy Details.
- (h) "Registering Authority" means the Assistant Labour Officer of the Area;
- (i) "Rule" means the Andhra Pradesh Unorganized Workers' Social Security Rules, 2012;

Note: Words and expressions used in this scheme and not defined shall have the same meaning assigned to them in the Unorganised Workers Social Security Act, 2008 and the Rules made there under.

3. FUND:

- I. A Fund shall be constituted in the name of "Andhra Pradesh Unorganised Workers Social Security Fund" by opening an Account in any Public Sector Bank Branch.
- II. The Fund shall consist of:-
 - a. Grants or Loans from the State Government;
 - b. Financial Assistance by the Central Government;
 - c. Interest on investment in securities, deposits and rent;
 - d. Donations etc., received from an individual or an establishment;
 - e. "Andhra Pradesh Transport Drivers Welfare Fund" constituted vide G.O.Ms.No.24 Dt.26-11-2014.
 - f. Apportionments from Other Welfare Funds, Welfare Boards and Welfare Schemes as per the directions of the Government.

Fund required towards annual premium for component Insurance Schemes viz., AABY and the State Group Accident Death and Disability Insurance Scheme and an amount not exceeding 10% on the premium towards administration charges shall be met by the A.P. Building and other construction Workers Welfare Board (APBOCWW Board), A.P. Labour Welfare Board in proportion to their workers covered under Chandranna Bima Scheme.

With regard to coverage of NREGA workers under the category of building and other construction workers, as per the mandatory directive of the Central Government (MOLE) under Section 60 of the Building and other Construction Workers (RE&CS) Act, 1996 vide Letter No.Z-20011/05/2010.BL of Ministry of Labour & Employment, GOI, dated 12.07.2013 all such workers who have completed 50 days of work in a year under MNREGA, shall be registered as building or other construction workers which is a category of Unorganised Workers. Rural Development Department shall take steps for their coverage under Chandranna Bima Scheme. They should also take steps by sending necessary proposals to the Labour Department for registration as Building Workers duly paying the subscription and registration fee and also pay Cess as per the Act.

Premium being paid by the Rural Development Department in respect of Abhaya Hastham Beneficiaries and Rural Landless Poor under AABY Scheme, Cess being collected under the Andhra Pradesh Transport Drivers Scheme shall be appropriated to "The Andhra Pradesh Unorganised Workers Social Security Fund" to incur the expenditure on Chandranna Bima Scheme. Any other Schemes implemented by other Departments with the same or similar benefits shall be regulated under intimation to the Commissioner of Labour and avoid duplication and appropriate their Budgetary Provision for use in the Chandranna Bima Scheme.

- g. Any other sums as may be notified or specified by the State Government;
- III. The Fund shall be applied for the purposes of this scheme. Without prejudice to the generality of powers in this respect, the Fund may be applied in connection with the following activities;
 - a. Cost of administering the scheme;
 - b. Payment of Premium for State Group Accident Death and Disability Insurance Scheme and the Aam Admi Bima Yojana (AABY) Scheme;

- c. Such other activities incidental to the objectives of the Scheme;
- IV. a. The Fund shall be administered by the Commissioner of Labour as per the procedures prescribed in the Financial Code and other established practices applicable for the Government Department to ensure financial propriety and accountability.
- b. The Commissioner of Labour shall send necessary proposals with details of procedure adopted and the amount required' to the Government and incur the expenditure as per the Government Orders on Premium, Administration of the Scheme and other incidental activities like Awareness Generation etc.,

4. REGISTRATION OF BENEFICIARIES :

All unorganised workers will be registered under the Unorganised Workers Social Security Act, 2008 through the Praja Saadhikara Survey being conducted by the State Government and enrolled as beneficiaries under Chandranna Bima Scheme. Assistant Labour Officer of the Labour Department having jurisdiction over the area where the Unorganised Worker is residing, shall be the Registering Authority.

5. BENEFITS UNDER THE SCHEME :

(i) Rs. 5,00,000/- (Rupees five lakh) Accident Death and Permanent Total disability relief:

Out of which Rs. 4,25,000/- (Rupees four lakh twenty five thousand) from the State Accident Death and Permanent Total Disability Scheme, Rs.75,000/- (Rupees seventy five thousand) under Aam Admi Bima Yojana (AABY).

(ii) Up to Rs.3,62,500/- (Rupees three lakh sixty two thousand five hundred) permanent partial disability relief:

Up to Rs. 3,25,000/- under the State Accident Death and Disability Scheme - Rs.37,500/- under Aam Admi Bima Yojana (AABY) .

(iii) Rs.30,000/- for Natural Death relief under Aam Admi Bima Yojana (AABY).

(iv) Rs.1200/- p.a. scholarship per child up to two children of the beneficiary studying 9th, 10th, Intermediate or ITI as a corollary to the AABY Scheme.

Note: The Benefits under the Aam Admi Bima Yojana Scheme are available to the Unorganised Workers in the Age Group of 18-59 years only and the Benefits under State Group Insurance Scheme are available for the age group of 18-70 years.

6. IMPLEMENTATION AGENCY RESPONSIBILITIES:

- (1) The Implementation Agency shall maintain data base, hard copies of signed applications and other connected matters and shall facilitate processing of the Claims under the scheme through Mahila Samakhya.
- (2)The beneficiary is required to pay to SERP Rs.15/- to meet the expenditure on registration and enrollment of unorganised workers, data entry, maintenance of hard copies of signed applications and other connected matters, communicating the Policy details with Policy Number and the Benefits, honorarium / incentive to Bima Mitras for claims investigation and support to nominees for filing of claim applications and Zilla Samakhya Insurance Call Center management and scholarship processing.

7. NOTIFICATION OF WORKERS FACILITATION CENTERS and CLAIMS PROCESSING

- (1) All Zilla Samakhyas, Mandal Samakhyas, Village Samakhyas, Slum Level, Town/ City Level Federations are hereby notified as Workers Facilitation Centers under section 9 of the Act, for facilitation of registration of unorganised workers, their enrollment in social security schemes, processing of claims and for delivery of such other services required for implementation of the scheme.
- (2) The District Call Centers of the Zilla Samakhyas under the SERP shall process the Claims under the scheme in coordination with the insurance agencies and ensure that claim amount is disbursed to the worker / family within 30 days from the date of receipt of the application. The SERP shall ensure coordination with and supervision over **Workers Facilitation Centers** with help line (Call Center) for this purpose for efficient delivery of services.
- (3) The benefits delivered by the insurance companies shall be paid to the Beneficiaries through online transfer to their bank account (Direct Benefit Transfer)

8. MONITORING COMMITTEES:

The Committee shall meet at monthly intervals and review the progress in implementation of the Scheme and submit a report before 5th of every month to the Commissioner of Labour, under copy to the Government in LET & F Department.

The Committee shall meet at monthly intervals and review the progress in implementation of the Scheme district wise and Insurance Company wise and submit a report to the Government before 15th of every month with specific observations and recommendations, if any, to improve the performance.

9. **REPORTING:** The Commissioner of Labour shall submit monthly Report to the Government on the Number of workers enrolled, eligible for claim benefits, no. of claims received, status of the claims with stage wise pendency, number

of claims paid and the amount delivered etc., Steps shall also be taken to link up the data with CM Dashboard and the Department Dashboard to exhibit realtime status of implementation of the Scheme.

10. Grievance Redressal:

Any grievance related to registration of worker, enrolment in the scheme and settlement of claims may be addressed to the PD, DRDA. An appeal lies to the District Collector

11. POWER TO REMOVE DIFFICULTIES:

If any difficulty or doubt arises as to the interpretation of any of the provisions of the Scheme, the decision of the Government shall be final and binding;

12. POWER TO AMEND SCHEME:

The State Government, by notification in the official Gazette, may modify or amend the Scheme for its proper implementation and in the interest of transport drivers;
