The following notification shall be published in Andhra Pradesh Gazette in English in the District Gazettes of Srikakulam, Vizianagaram and Visakhapatnam Districts in Telugu also.

NOTIFICATION

In exercise of the powers conferred on me under Sub-Sec(1) of Sec.31 of A.P. Shops and Establishments Act, 1988 read with G.O.Ms No. 844 Labour & Employment, Nutrition & Tech. Education (Lab-II) Department dated 10.12.1979, I, Joint Commissioner of Labour, Visakhapatnam hereby notify after consultation with Employers' Associations and Employees Unions of the Shops & Establishments, **09 (Nine)** Festival and National Festival Holidays each of 1 whole during the Calendar Year **2018** as specified in the Annexure to this notification for all the employees working in all the Establishments and as defined under Sec.2(10) of the said Act in **Srikakulam, Vizianagaram and Visakhapatnam Distracts and every such holiday, all the Shops & establishments shall observe Holiday / paid Holiday as per their convenience.**

The Employers are requested to implement the above as per Sec.3 of the A.P. Factories & Establishments (National Festival And Other Holidays) Act,1974 and in case under any extraordinary circumstances if any employee is made to work on any day of the above Holidays he is entitled twice the wages.

In case of default by the employer to pay the above, the employee is entitled to recover the same under Payment of Wages Act, 1936 as per Sec.8 of the Act. The Employers who contravenes the above provision are liable for prosecution under Sec.9 of the Act.

NOTIFICATION

In exercise of the powers conferred on me under Sub-Sec(1) of Sec.3 of A.P. Factories and Establishments Act, 1974 and Rules made thereunder read with G.O.Ms No.966 Employment and Social Welfare (Lab-II) Department dated 20.12.1974, I, Joint Commissioner of Labour, Visakhapatnam hereby notify after consultation with Employers' Associations and Employees Unions, **08 (Eight)** Festival and National Festival Holidays each of 1 whole during the Calendar Year **2018** as specified in the Annexure to this notification for all the employees working in all the Factories and as defined under Sec.2(a) of the said Act in **Srikakulam, Vizianagaram and Visakhapatnam Districts** and every such holiday, all the factories shall observe Holiday / paid Holiday as per their convenience.

The Employers are requested to implement the above as per Sec.3 of the Act and in case under any extraordinary circumstances if any employee is made to work on any day of the above Holidays he is entitled twice the wages.


