

INTER STATE MIGRANT WORKMEN (RE&CS), 1979 AND AP RULES, 1980 (PRINCIPAL EMPLOYER ESTABLISHMENT).

Procedure for making application for grant of License /renewal of License of Contractor Establishments under A.P. (Issuance of Integrated Registration and Furnishing of Combined Returns under Various Labour Laws by certain Establishments) Act, 2015(amended in 2016) and covered by Contract Labour(R&A) Act, 1970 And AP Rules, 1971.

Applicability:

The act applied to every establishment in which 5 or more inter state migrant workmen are employed or were employed during any day in the preceding 12 month.

Grant of Certificate of Registration to Principal Employer's establishment:

Every Principal Employer of an establishment covered under the Act shall register his establishment by submitting application form in Form-A and obtain Certificate of registration.

How to make application for license/renewal of license:

Application for Registration / renewal of registration will soon be available online through <http://ap.meeseva.gov.in/> . Once online service is available the license fee can be paid in the citizen service center or through online payment. System generated Registration Certificate will be available on the spot.

Fee payable by the Principal Employer:

Validity of Registration and renewal:

The registration certificate granted under the A.P. Integrated Registration Act, 2015 shall be valid up to 31st March of the 3rd year and the registration shall be renewed before 31st March of the 3rd year for a further period of 3 years.

Registering Authority:

The following officers of Labour Department have been notified as licensing authorities. (G.O.Ms.No.30 of LET&F Dept. Dated:27.08.2002)

1. Dy. Commissioner of Labour: up to 300 workers
2. Jt. Commissioner of Labour: above 300 workers

How to make application for Registration / renewal of registration:

Application for Registration /renewal of registration shall be submitted online at <http://ap.meeseva.gov.in/> and the license fee as specified above shall be paid in the citizen service center or online payment. A System generated license will be available on the spot.

Online Application and Payment: Application for License /renewal of License shall be submitted online through the Single Desk Portal <https://www.apindustries.gov.in/> or Online Meeseva portal <https://onlineap.meeseva.gov.in> by filling in the Integrated Registration form. After online payment of license fee as specified above, a system generated registration certificate is downloadable on the spot.

Application through Meeseva Citizen Service Centers: Application form for registration / renewal can be downloaded from Meeseva portal: http://ap.meeseva.gov.in/DeptPortal/Application%20Forms%20New/Labou_r-Pdf/Integrated%20Application%20Form.pdf

Filled in application forms can be submitted at Meeseva citizen service centres. Department user can login on <http://ap.meeseva.gov.in/> to submit applications and process payments on behalf of applicant. System generated certificates are then given to applicants instantly.

How to make application for license/renewal of license:

Application for license/renewal shall be submitted online at <http://ap.meeseva.gov.in/> and the license fee as specified above shall be paid in the citizen service center or online payment. A System generated license will be available on the spot.
