ORDER:

In the G.O. 2nd read above, orders were issued notifying the “Chandranna Bima” a Social Security Scheme to provide Natural death, Accident death and Disability Insurance and also other benefits for the unorganized Workers in the State. The said orders are in operation from 30.09.2016 to 02.10.2017.

2. In the D.O. Letter 3rd read above and meeting in reference 4th read above, the Ministry of Labour and Employment, Government of India have proposed for convergence of Aam Aadmi Bima Yojana (AABY) with Pradhan Mantri Jeevan Jyothi Beema Yojana (PMJJBY) and Pradhan Mantri Suraksha Bima Yojana (PMSBY) for the AABY beneficiaries in the age group of 18-50 years, for the age group 50-60 years existing AABY shall continue and the PMSBY scheme operates from 18-70 years. In addition, it has also been clarified by the Government of India that Scholarship and Disability insurance shall continue as per the existing schemes. The Government of India has solicited the concurrence of the State Government for convergence and payment of premium on 50:50 basis between Government of India and State Government.

3. In the letters third read above, the Commissioner of Labour while recommending the convergence of AABY with PMJJBY & PMSBY for providing insurance coverage to the unorganized sector workers in the State as proposed by the Government of India, has furnished detailed proposal for convergence and its implementation towards Chandranna Bima. The Commissioner of Labour has requested to approve the convergence scheme.

4. Government, after careful examination, hereby convey the concurrence for participating in the convergence scheme of Aam Aadmi Bima Yojana (AABY) with Pradhan Mantri Jeevan Jyothi Beema Yojana (PMJJBY) and Pradhan Mantri Suraksha Bima Yojana (PMSBY).

5. The implementation of convergence Scheme will be commenced from 2nd October, 2017 upto 31st May, 2018 (8 months), in association with Chandranna Bima Scheme, with proportionate payment of premium for 8 months.

6. A separate head of account for Chandranna Bima for payment of premium to unorganized sector has been agreed for creation.

7. Accordingly, the Commissioner of Labour will take further necessary action and send proposals for Chandranna Bima – II (for the period from 2nd October, 2017 to 31st May, 2018) for operation of the Convergence Scheme in association with the Chandranna Bima Scheme. He will also, further, send proposals for the funds required under the Chandranna Bima head of account, duly showing the details of total fund requirement, funds tied up from Andhra Pradesh Building and Other Construction Workers Welfare Board, (APBOCWVB) Transport Cess etc and funds required from Government Head of account.
