The following notification will be published in the next issue of the Extra-ordinary Gazette of the Andhra Pradesh:

NOTIFICATION

In exercise of the powers conferred under sub-section (4) of section 3 of the Unorganized Workers’ Social Security Act, 2008 (Central Act No.33 of 2008), Government hereby make the following Amendment to the “Chandranna Bima” a Social Security Scheme issued in the G.O.Ms.No.54, LET & F (Lab.I) Department, Dt:30.9.2016.

AMENDMENTS

In the said G.O.,-

I. Under the sub-heading “Salient Features of the Scheme”, -

(1) After Point No.5 (iv), the following shall be added, namely,-

“(v) Society for Elimination of Rural Poverty shall initially pay the amount of Rs.5,000/- (Rupees Five thousand only) towards funeral charges to the nominee of the deceased from its funds as is being done presently by Society for Elimination of Rural Poverty;

(vi) The above amount shall be recouped by Society for Elimination of Rural Poverty when the claim amount is received from the Insurance Companies”;

(2) After point No.8, the following shall be added, namely,-

“9. Society for Elimination of Rural Poverty will set up Grievance Redressal Mechanism to see that proper and timely settlement of claims and to ensure effective redressal of grievances.”

II. in Annexure-I appended to the said G.O.:-

(1) Under Point No.5 “Benefits under the Scheme”, after sub-point No.(iv), the following shall be added, namely,-

“(v) Society for Elimination of Rural Poverty shall initially pay the amount of Rs.5,000/- (Rupees Five thousand only) towards funeral charges to the nominee of the deceased from its funds as is being done presently by Society for Elimination of Rural Poverty.

(vi) The above amount shall be recouped by Society for Elimination of Rural Poverty when the claim amount is received from the Insurance Companies”;

(2) Under point No.10 “Grievance Redressal”, after existing text, the following shall be added as separate para, namely,-

“Society for Elimination of Rural Poverty will set up Grievance Redressal Mechanism to see that proper and timely settlement of claims and to ensure effective redressal of grievances.”
