In the G.O. 5<sup>th</sup> read above orders were issued mentioning the Scheme Profile of the 2<sup>nd</sup> year Chandranna Bima and its implementation as per eligibility conditions & guidelines issued vide G.O.Ms. No. 54, LET&F (Lab.I) Department, Dt:30.09.2016, as amended from time to time. Further, directions issued on approximate total premium relief to be paid to the Insurance Companies and its share to be borne by different Boards involved and also for expenditure for launching of the Chandranna Bima Scheme event on October 2<sup>nd</sup> 2017.

In the letter 6<sup>th</sup> read above, the Commissioner of Labour while furnishing the 2<sup>nd</sup> year Chandranna Bima Scheme based on the instructions given by the Hon’ble Chief Minister, has proposed for change of the title of Chandranna Bima Scheme in view of the Central Government schemes and contribution involved.

5. After careful examination, Government hereby modify the title of the Scheme “CHANDRANNA BIMA” as “PMJJBY- CHANDRANNA BIMA”.

6. The Commissioner of Labour, A.P., Vijayawada shall take further necessary action accordingly.
