ORDER:

In the G.O. 1st read above, Government have issued orders to provide insurance and other benefits to the two(2) crores estimated Unorganised workers in the state who are in the age group of 18-70 years and drawing monthly wages less than Rs.15,000/-.

2. In the letter 2nd read above, the Commissioner of Labour has reported that as per the Praja Sadhikara Survey 2,13,54,251 enrolled as unorganised workers under Chandranna Bima scheme as on 31.03.2017 as per the norms specified in the G.O. 1st read above and requested the Government to sanction additional Premium towards payment to the Insurance companies (LIC&OIC) to obviate the possibility of technical objections of honouring the claims.

3. The details of the Un – organised workers and Calculation of Payment of Additional Premium to Insurance Companies is appended to the annexure.

4. After careful examination, Government hereby sanction additional premium of Rs. 8,73,22,716/- (Eight Crores Seventy Three Lakhs Twenty Two Thousand and Seven Hundred Sixteen Rupees Only) towards payment to the LIC & OIC to cover the additional members under Chandranna Bima scheme. The amount shall be drawn as an advance from Andhra Pradesh Building and Other Construction Workers Welfare Board.

5. The amount sanctioned at para (4) above, shall be treated only as an advance Premium. It is possible that more people will be registered or there will be changes under Chandranna Bima through the PSS. Hence, this amount is to be presently treated as an advance towards premium and final settlement will be done once the numbers are finalized on completion of PSS.

6. The amount of premium paid earlier and including the above sanctioned amount (additional Premium) drawn as an advance from Andhra Pradesh Building and Other Construction Workers Welfare Board under Chandranna Bima Scheme shall be adjusted among the Building and Other Construction Workers, Transport Workers proportionately as per PSS survey and the Commissioner of Labour shall send requisite proposals for adjustment to be met from Andhra Pradesh Building and Other Construction Workers Welfare Board, Transport cess funds maintained by Commissioner of Labour and the reimbursement to be sanctioned by the Government at the earliest.
