ORDER:

In the G.O. 1st read above, Government have issued orders to provide insurance and other benefits to the two (2) crores estimated Unorganised workers in the state who are in the age group of 18-70 years and drawing monthly wages less than Rs.15,000/-.

2. In the G.O. 2nd read above, an amount of Rs. 8,73,22,716/- (Eight Crores Seventy Three Lakhs Twenty Two Thousands and Seven Hundred and Sixteen Rupees only) sanctioned to the Life Insurance Corporation(LIC) & Oriental Insurance Company (OIC) towards Premium for the additional unorganised workers enrolled as per the Praja Sadhikara Survey for covering under Chandranna Bima scheme. Out of the said amount of Rs. 8,73,22,716/-, an amount of Rs. 2,16,68,016/- was sanctioned to the OIC @ Rs.16/- for the period of six months (from 02.04.2017 to 01.10.2017), which is half of the premium of Rs.32/- per head.

3. In the letter 3rd read above, the Commissioner of Labour has reported that the Chief Regional Manager, The Oriental Insurance Company Limited their mail has stated that the Chandranna Bima policy is a specifically designed tailor made policy at concessional rate of premium where the premium is not subsidized by any scheme sponsored by the Government of India and this policy is akin to the Pradhan Mantri Suraksha Bima Yojana(PMSBY) Policy introduced by the Government of India, where there is no provision for charging pro-rata premium for midterm inclusion while the cover expires on the date of expiry of the Master Policy. Hence, Chief Regional Manager has requested to consider the payment of full premium @ Rs. 32/- per head amounting to Rs. 4,33,36,032 to provide necessary coverage to the additionally enrolled members from the remittance of such premium. The Commissioner of Labour requested for orders in the matter.

4. After careful examination of the matter, Government hereby agree for payment of Rs. 32/- per head in respect of 13,54,251 members of unorganized workers enrolled additionally for coverage under Chandranna Bima Scheme and sanction an amount of Rs.2,16,68,016/- to the Oriental Insurance Company Limited.
