Sub: ESTABLISHMENT – LABOUR DEPARTMENT – Public Services – Transfers and Postings of Employees – Lifting of ban on transfers from 05-05-2018 to 04-06-2018 – Orders issued – Instructions – Reg.

Ref: G.O.Ms.No.54, Finance (HR.I.PLG.&POLICY) Dept., dated 02-05-2018.

Through the reference cited, Government have issued guidelines on transfers of employees while relaxing ban on transfers for the period from 05-05-2018 to 04-06-2018 to ensure right placement of employees to improve efficiency and accountability in administration. In the said orders, the Government have permitted to consider transfers only on the grounds of **i) Mutual and ii) on request**. As per the said instructions, the employees who fulfilled the following conditions shall apply for their transfer.

- a) The employees seeking transfer on mutual and on request shall have completed (3) years of continuous service in all cadres at the present station as on 02-05-2018. Such transfers shall not be done between the offices located in the same station.
- b) The request transfer shall be considered against existing clear vacancy.
- c) The request transfers shall be considered in respect of employees fulfilling one or more of the conditions mentioned below:
  - i) Visually challenged persons
  - ii) With disability of 40% or more
  - iii) Husband and Wife cases (only one spouse shall be shifted) (once the facility is utilised, the next request can be made only after eight years.
  - iv) Employees having mentally challenged children to place where medical facilities are available.
  - v) Widow employee appointed on compassionate basis.
  - vi) Medical grounds for the diseases of Cancer, Open Heart Operation, Neuro Surgery, Kidney Transplantation to place where such facilities available (either self or spouse or dependent children and dependent parents).
  - vii) based on the above conditions preference shall be given to the employees with the longest tenure at a particular duty station, seniority in the cadre and outstanding performance.

In view of the above the vacancy position in the Cadre of Joint Commissioner of Labour/ Dy.Commissioner of Labour and Asst.Commissioners of Labour in the State is as follows:-
